

# MEMORANDUM OF UNDERSTANDING (MoU) RENEWAL

This Memorandum of Understanding (hereinafter referred to as the "MoU") is hereby renewed on 01/11/2023 by and between:

Grace Palliative Care, Mukkam. Acting through its authorized signatory Mr.Shareefudheen.P.K, Chairman, (hereinafter referred to as the "Second Party", which expression, unless excluded by or repugnant to the subject or context, shall include its successors-in-office, administration, and assigns)

(First Party and Second Party are hereinafter jointly referred to as the "Parties" and individually as the "Party")

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

#### Background

Both parties have previously entered into anMoU and have successfully collaborated on various initiatives in line with their common interests and objectives. The Parties have established effective channels of communication and cooperation, aiming to promote and advance their respective operations within their institutions and related wings. They have shared relevant information and opportunities to support each other's growth.

The cooperation between the First Party and the Second Party has proven to be beneficial in utilizing the intellectual capabilities of the First Party's faculties and developing suitable teaching/training systems aligned with the needs of society.

## Purpose

The main purpose of this MoU renewal is to continue utilizing the expertise of the Second Party in sensitizing the students of the First Party on social issues, with a special focus on nursing practices of Pain and Palliative Care.

## Funding

This MoU renewal does not entail any financial obligations between the Parties. It is solely intended to sensitize students on social issues and make the expertise of the Second Party available to meet the requirements of both parties on a service basis.

#### Duration

This MoU renewal shall be effective from the date of signing and shall remain in effect for a period of Ten Years from the original MoU's expiration date. This MoU will be valid until it is expressly terminated by either Party on mutually agreed terms. Both Parties may terminate this MoU upon providing 30 calendar days' written notice. In the event of termination, both parties shall fulfill their respective obligations.
