## RENEWAL OF MEMORANDUM OF UNDERSTANDING (MOU)

(First Party and Second Party are hereinafter jointly referred to as the "Parties" and individually as the "Party")

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

# Background

Both parties share common interests and objectives, and they have established effective channels of communication and cooperation to promote and advance their respective operations within their institutions and related wings. The Parties shall continue to inform each other of potential opportunities and share relevant information to secure additional opportunities for one another. Both parties believe that their close cooperation will greatly benefit the student community, enhancing their commitment to society and fostering empathy towards the needy.

## Purpose

The main purpose of renewing this MOU is to continue utilizing the expertise and resources of the First Party for the upliftment of the Second Party and to provide Health Education, Awareness, Physical fitness, and quality of life improvement for blind persons.

### Funding

The renewal of this MOU does not entail any financial obligations between the Parties. It is solely meant for sensitizing students on social issues and making the expertise of the First Party available to meet the requirements of both parties on a service basis.

#### Duration

This MOU renewal shall be effective from the date of signing and shall remain in effect for a period of 10 years from the expiration date of the original MOU. This MOU will be valid until it is expressly terminated by either Party on mutually agreed terms. Both Parties may terminate this MOU upon providing 30 calendar days' written notice. In the event of termination, both parties shall fulfill their respective obligations.
