ORDER

University vide paper read (1) above, invited applications for continuation of provisional affiliation for the academic year 2019-20, from the colleges for courses affiliated to the University. The Principals of the colleges/institutions conducting B.Sc MLT course submitted application for Continuation of provisional Affiliation for the academic year 2019-20, with necessary fee.

2) While conducting inspections in the above colleges for the grant of Continuation of Provisional Affiliation for the year 2019-20 it came to the notice of the University that faculty in cadre posts of Professor / Associate Professor in core subjects were deficient in most of the colleges though these colleges were having the total number of faculty (irrespective of cadre) in core subjects as per norms. In reply to the University directions to rectify the faculty deficiency in the cadre posts of Professor / Associate Professor, these colleges represented to the University to relax the existing norms of faculty requirement, as there is an acute shortage of faculty in core subjects having the required experience and qualifications to be posted as Professor or Associate Professor. Further they represented that only two institutions under the University are now conducting PG courses in MLT and that only with limited PG seats which is not sufficient to meet the current requirement of experienced Post Graduate teachers in all affiliated institutions.

3) As the cut off date for admissions to the course was nearing, considering the urgency the matter was placed before the Sub Committee of the Governing Council for taking urgent decisions between the Governing Council meetings, on 03.07.2019.

5) The college shall strictly adhere to the following conditions:-

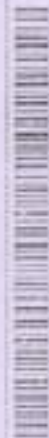

4) Subsequently the following paramedical institutions has intimated that they have engaged Medical Faculty of their Medical College for teaching MLT courses and submitted compliance report .The Scrutiny committee on verification of the compliance report has not pointed out any deficiency in the colleges but only directed to verify the enrolment status of Medical Faculty in MLT discipline in FEP and to give COPA for the year 2020-21.

5) On verification with the FEP data , all the medical faculty engaged in teaching MLT course is found registered in FEP under the Medical stream. All the colleges submitted declaration that the medical faculty engaged are willing to take part in examination duties including practical and theory evaluation.

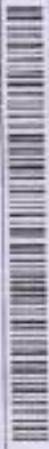
ORDER

- The College should remit annual administration fee fixed for UG and PG courses for the academic year 2023-24.(Except Government Colleges)
- Admission to the next academic year shall be made only after obtaining prior permission from the University.



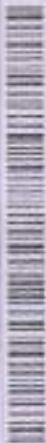

ORDER

In accordance with the provisions prescribed under section 53 of KUHS act 2010 and with the provisions of the modified affiliation statute, in order to verify the facilities available in KMCT College of Allied Health Sciences, Kozhikode for the continuation of provisional affiliation to conduct B.Sc. Optometry course with 30 seats, University conducted inspection in the college and examined all the documents related to the processing of application submitted by the college authority. 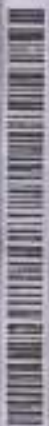

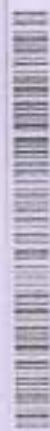

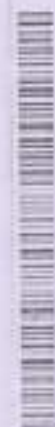
