ORDER

1. As per paper read as 1st above, the proposal of Dean Students Affairs to grant maternity leave for the female students studying in the institutions affiliated under KUHS was placed before the 33rd Academic Council Meeting held on 17.02.2023.
2. As per paper read as 2nd above, the 33rd Academic Council discussed this issue in detail and for ensuring the health of the next generation & the mother ,it is decided to grant Maternity leave up to 6 months that can be sanctioned by the Head of the institution concerned and the same to be reported to the University. The course period will get extended for a period equal to leave period. As the Condonation of break of study can be granted by the concerned Head of the Institution , no fee for this purpose is to be paid to the University in relation with the maternity leave.
3. As per paper read as 3rd above, the Governing Council has approved the recommendations of the 33rd Academic Council regarding granting 6 months maternity leave to the female students above 18 years of age and the same has been implemented vide paper read as 4th above.
4. In the circumstances, accordance with the decision of the 73rd Governing Council Meeting, sanction is hereby accorded to implement to grant maternity leave up to six months to the female students above 18 years of age studying in the institutions affiliated under KUHS by the Head of the institution concerned and reported to the University, observing the points mentioned in para 2 above.
5. The Governing Council Decision is therefore implemented.
